

The maximum age limit for appointment by transfer on deputation (including short-term contract)/transfer shall not be exceeding 56 years as on the closing date of receipt of applications).

Only officers of the Central/State Governments/ Union Territories will be eligible for being considered for appointment on Transfer basis.

Superintendent Group – B (Non-Gazetted) (Ministerial) – One Post

Note 4: For the purposes of computing minimum qualifying service for deputation, the service rendered on a regular basis by an officer prior to 1st January, 2006 or the date from which the revised pay structure based on the recommendations of the Sixth Central Pay Commission has been extended, shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the said Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where this benefit will extend only for the post(s) for which that grade pay or pay scale is the normal replacement grade without any upgradation.

The officers selected for the posts will have the option to either draw his grade pay in the parent cadre plus deputation (duty allowance) or to draw the pay in the scale of pay of the deputation posts as may be fixed in accordance with the existing orders. The rate of deputation allowance will be regulated in terms of the Department of Personnel & Training's orders contained in their O.M. No.2/22(B)/2008-Estt.(Pay-II) dated 03 09 2008 and amended time to time.

Candidates applying for the post will not be allowed to withdraw their names later.
