In this context it is informed that three new criminal laws namely the Bharatiya Nyaya Sanhita, 2023, The Bharatiya Nagarik Suraksha Sanhita, 2023 and the Bharatiya Sakshya Adhinyam, 2023, have been passed by the Parliament and after the assent of the Hon'ble President of India, have been notified in the Gazette of India on 25th December, 2023. These new laws will replace the Indian Penal Code, 1860, the Code of Criminal Procedure, 1973 and the Indian Evidence Act, 1872 respectively. A copy of the Gazette Notifications dated 4th February, 2024 in this regard are enclosed for your reference.

Therefore, it is requested to undertake mass awareness generation campaign for the general public and other stakeholders highlighting various features of the new laws.

As you are aware that the three new Criminal Laws namely the Bharatiya Nyaya Sanhita, 2023, the Bharatiya Nagarik Suraksha Sanhita, 2023 and the Bharatiya Sakshya Adhiniyam, 2023, have been passed by the Parliament and after the assent of Hon'ble President of India, have been notified in the Gazette of India on 25th December, 2023. These three Acts will replace the Indian Penal Code, 1860, the Code of Criminal Procedure, 1973 and the Indian Evidence Act, 1872 respectively.


2. The Central Government has appointed the 1st day of July, 2024 as the date on which the provisions of the Bharatiya Nyaya Sanhita, 2023 (45 of 2023), the Bharatiya Nagarik Suraksha Sanhita, 2023 (46 of 2023) and the Bharatiya Sakshya Adhiniyam, 2023 (47 of 2023) shall come into force. A copy of the Gazette Notifications dated 24th February, 2024 in this regard are enclosed for your reference.

3. The Ministries/ Departments are requested to undertake mass awareness generation campaign for the general public and other stakeholders highlighting various features of the new laws.
