Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

HONEY PROCESSING MACHINE

The Complete Unit Consists of following-

1. Hot Processing Tank

Capacity: 200 KG in 8 Hours

Insulated hot water jacket tank, made of Food Grade SS 304, Fitted with Stirrer having required rpm, This hot processing tank is also fitted with the temp. Sensor, which can be adjusted according to the level of the honey inside the tank.

2. PRIMARY FILTER:

The Primary filter works to remove coarse impurities and makes honey more flow able, MOC: SS 304 with removable / washable and changeable filter screen.

3. GEAR PUMP WITH MOTOR-1 No

Reputed make Gear pump is used in the machine to provide durability.

4. BAG FILTER

High pressure filter with top lid open type with fasteners, inside perforated basket with 100 microns filter cloths. Top inlet, bottom drain & air vent with valve.

5. MOISTURE REDUCTION UNIT

Made of SS 304, top open able type with lock nuts. Inside perforate plates with supports and bottom hot air nozzle with heating chamber, 2 KW heaters & 1 HP blower and control panel can provide. Moisture reduction upto 17%.

6. STORAGE TANK

Capacity: 200 litres

Made of SS 304, Mounted on Machine Frame

7. Pipes & Fittings – All ss304

8. MOUNTING FRAME: - 1 No MOC: SS

Electric Panel of the machine is made by using all reputed make switch gears and all the wires and cables are used of top quality

BUYER ATC:

- Average Annual Turnover of the bidder must be above 30lakhs for the last three financial year.
- It is mandatory for every Bidder to submit an undertaking on Rs.100 stamp paper confirming Non-Blacklisting of his firm in any manner whatsoever.
- Bidder or its oem direct or through resellers must have supplied machines to any state government departments in past 2years and work order confirming the same should be uploaded with bid documents
- EMD submission is mandatory for every bidder.
- It will be mandatory to attach the attested copy of GST No of the firm with the tender Documents.
- Every bidder needs to do installation, training and one year on site maintenance support.
- Delivery location of all machines will be as per instruction provided in Pre-Bid Interaction meeting.
- The payment will be made only after the quality of the materijal supplied by the firm is tested by the local technical committee and after being fully satisfied by the forest division officer.
- In case of any dispute the decision of the Divisional Forest Officer, West Forest Division (T), Betul will be final and acceptable.
- It is mandatory for the bidder to provide escalated customer support number for the machinery issues if any in future.
- Preference will be given for the bidder from Madhya Pradesh.
